- Ensure the successful implementation of OMP for rough cut capacity planning (RCCP) and batch
 planning (Scheduling), combined with SAP manufacturing process including resources, recipe, BoM
 and order management.
- Guarantee material staging and consumptions in production to allow all timely seamless operations
- Act as an interface for the operations and the logistics requirements to ensure a seamless flow between the systems, e.g. SAP and OMP. But it also includes good collaboration with further roles, as supply planning, scheduling, logistics and other supply chain functions.
- Creation of performance measurements (KPI) regarding material consumptions, execution reliability and discipline (Timely and accurate update of the systems).
- The role is accountable to document the process' (e.g. creation and maintenance of SOPs) in the field of responsibility.
